Like previous elections, each nomination package must include signatures from 3 eligible nominators. Candidates, nominators, and voters must be CUPFA members who are *eligible* based on having a teaching or course remission contract in the 2025-2026 academic year.

New electronic election procedures require these 3 eligible nominators to communicate their nomination statement in support of your candidacy for a specific executive position via email sent directly to the Chief Returning Officer. A confirmation will be sent to the nominator and candidate.

**Your nomination will be incomplete without these three required email endorsements.**

For example, you may request that an eligible nominator send a brief statement to Chief Returning Officer, CUPFA elections 2026, Me Sarah-Isabelle Avril at [savril@gattusogbm.com](mailto:savril@gattusogbm.com) (cc to you if preferred) by Tuesday, January 13, 2026:
